### Apply for your education benefit

For VA education benefits-Chapters 30, 31, 33 and 1606, apply online at <a href="https://www.va.gov/education/how-to-apply/">https://www.va.gov/education/how-to-apply/</a>. If you have any questions about which benefit to choose, call the VA Hotline at 1-888-442-4551.

Documents and information to have when applying:

- ★ You will need your social security number of the number of the veteran you are claiming dependent benefits from
- ★ Bank account direct deposit information
- ★ Education and military history
- ★ Basic information about the school or training facility you want to attend or are attending now

For Tuition Assistance, prior to enrolling in your classes, contact your Educational Service Office or counselor within your unit to see how to apply for tuition assistance.

### **Complete a VA Certification Request in your SCC Student Portal**

- ★ Log in to your MySCC Student Portal. Under Quick Links>Eforms>Forms>Certify My VA Benefit form. For VA education benefits, you can upload your Certificate of Eligibility (COE) along with your Certify My VA Benefit or in person to the Financial Aid Office/Veteran Services office.
- ★ For Tuition Assistance notify Financial Aid Office/Veteran Services that your tuition assistance is approved.

### **Pay Tuition and Fees**

- ★ If you are receiving education benefits under Chapter 31 (VA VR&E) or Chapter 33 (Post 9/11), the VA will pay your tuition and fees directly to SCC.
- ★ Veterans who receive Chapter 33 benefits are responsible for their book charges and must have these paid prior to the start of each term.
- ★ Students with Chapter 30, 35, and 1606 education benefits will be responsible for paying SCC directly.

If your tuition assistance is approved, you must contact Veteran Services and provide proof of approval. If approved and you notify Veteran Services prior to the tuition payment deadline, you will be held in your courses. If your tuition assistance is not approved, or you fail to contact Veteran Services prior to the tuition payment deadline, you will be

responsible for paying any tuition and fee charges by the deadline to avoid being dropped from your courses. Failure to pay before the payment deadline will result in your being dropped from your courses.
